- ~ The National Adoption Day celebration will be held at the courthouse from 10 AM to 12 PM on November 18th.

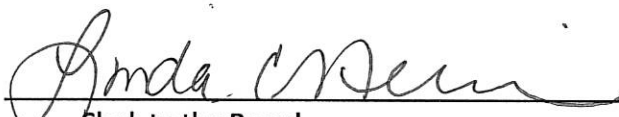
Board Members' Time – Chairman Barg
